Outstanding Doctoral Supervisor of the Year Award

1. Purpose of the Scholarship

The purpose of the scholarship is to recognize those doctoral students of Semmelweis University who perform outstanding work in mentoring the next generation and, as supervisors, contribute to their students' TDK/OTDK competition results and scientific achievements.

2. Eligibility

Applications may be submitted by any:

- full-time, part-time, or individual preparation doctoral student, or doctoral candidate who obtained the absolutorium no more than one year ago,
- from any doctoral school of Semmelweis University,
- who, in the given year, supervised at least one TDK student who received an award **and** was the first author of the TDK project.

3. Evaluation System

Only the results of students supervised by the applicant within officially verified TDK supervision may be considered.

1. TDK and OTDK Results

Condition: Points for placement may only be awarded if the supervised student is the first author of the TDK project.

II. Number of Supervised TDK Students

Number of active TDK students supervised in the given year: **0.5 points per student**

III. Publication Points (based on the authorship position of supervised students)

Only publications meeting the following criteria may be considered:

- The student and the doctoral student are co-authors.
- Scoring is based on the student's authorship position.
- The year of acceptance counts, regardless of publication date.

Eligible publication types:

- original research article
- review article

Not eligible: case report, letter, commentary, editorial, etc.

A) Journal Quality (based on the latest Scimago Journal Ranking)

Journal Category Points

D1	4 points
Q1	3 points
Q2	2 points
Q3–Q4	1 point

B) Student Authorship Position

- First or last author → **+2 points**
- Other authorship → **+1 point**

If multiple supervised students appear in the same publication, the journal-quality points (A) are counted only once, but each student's authorship bonus (B) is added.

4. Determining the Result and Award

The doctoral student with the highest total score receives the award, which is presented at the opening ceremony of the internal TDK conference following the academic year.

In addition to the certificate, the awardee receives a one-time **300,000 HUF scholarship** from the budget of the Doctoral Student Union (DÖK). In the event of a tie, multiple awardees may be selected; each receives a certificate, and the scholarship is divided equally.

5. Grounds for Exclusion

Applications may not be submitted by individuals who are under disciplinary proceedings or whose student status is suspended.

6. Application Procedure

The call for applications is published annually by the DÖK. Applications must be submitted electronically via the platform or email address specified in the call.

Required Documents

- Completed application form (including scoring)
- TDK certificate verifying results and supervision
- List of referenced publications (MTMT) or first pages of the articles

Only properly verified items may be considered in the scoring.

Deadline: As specified in the current call for applications. No additional documents may be submitted after the deadline.
