(hereinafter jointly referred to as **Parties**), on the date and at the place written below under the following terms and conditions:

This agreement sets out the terms and rules applicable to the work performed during the internship by the 1st/3rd/4th/ 6th year student of Semmelweis University Faculty of General Medicine for ~~summer patient care / summer internal medicine / summer surgery / rotation year internal medicine / rotation year surgery / rotation year paediatrics / rotation year obstetrics / rotation year neurology / rotation year psychiatry.~~

1.) The **Parties** agree to **enter into a definite-term agreement for the period of the internship** specified in Section 7 in accordance with Section 44 of Act CCIV of 2011 on National Higher Education requiring the provisions of the Labour Code to be applied to the employment of the student performing work under this agreement, with the provision that more favourable terms may apply as set out in government decrees.

2.) According to Government Decree 230/2012. (VIII.28.), in the course of the employment of a student performing work under a student agreement, the student may not be required to work at night nor other extraordinary working hours, the daily working hours of the student may not exceed 8 hours, in the event a work time frame is used, a maximum work time frame for one week may be ordered, the student must be provided with at least a 12-hour rest period a day, no probation period may be ordered and the provisions of Sections 105(2) and 106(3) may not be applied.

5.) The responsibilities assigned to the student for the period of the internship are included in the placement syllabus.

8.) **The period of work for ~~summer patient care / summer internal medicine / summer surgery / rotation year internal medicine / rotation year surgery / rotation year paediatrics / rotation year obstetrics / rotation year neurology / psychiatry~~ internships shall be 40 hours a week. In the context of the final year practices biweekly students can be scheduled either to a maximum 12 hours weekend shift or to a night shift on the students' choice.**

9.) The Parties agree that the student **is not entitled to remuneration or benefits** for the duration of the internship.

10.) The person responsible for professional issues at the place of internship:

11.) The person responsible for issues connected with the institution of higher education at the place of internship: Professor Dr. Tamás Masszi, Vice Dean for Educational Affairs.

12.) The **place of internship** provides professional supervision and direction for the placement activity, as well as the facilities and equipment for performing the placement work.

13.) Professional supervision and direction is provided by the person responsible for professional issues at the place of internship.

14.) The place of internship agrees to provide the student with a practical part internship as specified in the placement syllabus, at a safe workplace in terms of labour health and safety standards.

15.) The **Student** agrees to follow the training schedule of the place of internship, to complete the internship according to the requirements, and to acquire the internship knowledge to the best of his/her abilities. Furthermore, the Student agrees to observe the HSSE requirements and not to demonstrate any conduct that may conflict with the legitimate business interests of the place of internship.

16.) This employment contract shall be effective for the term specified in Section 7.

For the rights and obligations of the Parties not regulated herein, the provisions of Act CCIV of 2011 on National Higher Education, Government Decree 230/2012 (VIII. 28.) on certain aspects of higher education, and internships in higher education, Act I of 2012 on the Labour Code and Act V of 2013 on the Civil Code shall apply.
