# Purpose of the personal-hygiene medical examinations:

is to considerate that **the medical condition of the employed person**

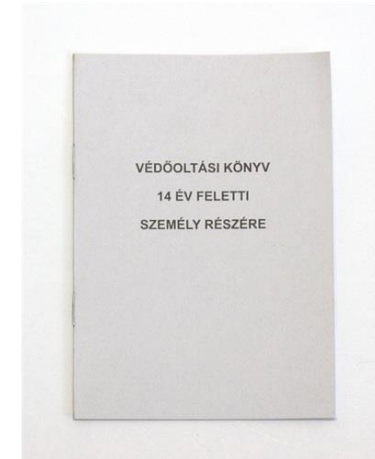
- during work-

**does not menace the health of other persons,** on work fields of heightened importance of epidemiological aspect, and is s/he able to enter employment at the given work field.

# Necessary test results

For registration:

- Negative chest X-ray and HIV result
- Negative Hepatitis C test
- Hepatitis B vaccination
- Microbiological test
- Declaration about your health status, chronic diseases



# Starting the practices

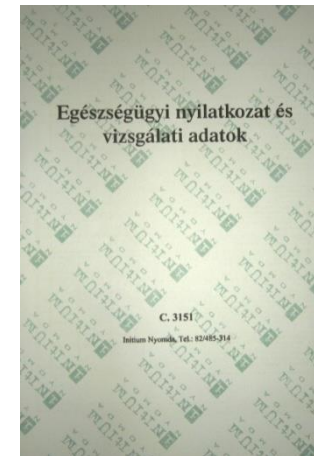
Every student needs to have valid aptitude test:

- Valid tbc (tuberculin ) test or chest X ray test, HIV test
- Completed Hepatitis shots
- These documents have to be recorded in Neptun ► Studies and Examinations Regulations. Sec. 18 (7) – (10)
- **In every semester ! Before you start the field training.**

# Studies and Examinations Regulations

Sec. 18 (7) Before starting their field practice the students are obliged to appear in a personal-hygiene aptitude examination (further on aptitude test). He/she may have the aptitude test either in the surgery room of the Faculty or any other institute authorized to perform an examination of this kind. In case the student attended this examination not in Semmelweis University, Faculty of Health Sciences, he/she is obliged to present the documents proving his/her aptitude in the surgery room of the Faculty – so that the aptitude be recorded in the Faculty's registry.

Sec. 18 (8) The organizational unit liable for organizing and arranging the examination keeps the register up-to-date about the required aptitude test, the attendance at it and the presentation of documents proving the aptitude. **It is suggested that students have the aptitude test completed /performed and recoded in September each academic year.**

Sec. 18 (9) In compliance with the regulations details about acquiring the certificate of aptitude for each training programme and specialisation separately are published on the homepage of the Faculty by the organizational unit liable for organizing and arranging the examination till the beginning of the exam session of the term prior to the given academic year.

Sec. 18 (10) The validity of the obligatory aptitude test is recorded in the students' information system by the organizational unit responsible for organizing and arranging the examination. ***Without the aptitude test being recorded the student cannot start the field practice.*** It is the duty of the organisational unit of instruction liable for organizing the given field practice to supervise whether the student has appeared in the obligatory aptitude test. To fulfill this obligation the organizational unit of instruction may use the registers recorded about the attendances at the obligatory aptitude test

Sec. 18 (12) The registration as by article (9) of this Section is the student's liability and duty. **If the student participates the field practice without registration in addition to his/her disciplinary liability the given field practice will be annulled and in case of any damage caused he/she will be held liable for it.**



# What is important for the medical examinations?

Negative results needed for the valid medical booklet:

## **For practices in adult care:**

- Chest X-ray / X-ray screening
- Dermatological test

## **For practices in children care and pregnancy units:**

- Chest X-ray / X-ray screening
- Dermatological test
- Fecal culture
- Lues-serology
- Throat culture

- For those healthy persons who have received the vaccination according to the vaccination scheme, reminder vaccination is not needed.



# In case of accident during the practical /field/ training

- Manage the first aid
- Inform the hosting provider
- Written record of event
- (how happened, character of accident, description of the first aid)
- Inform soon the surgery office of the Faculty
- Manage the further safety activities ( serological test, vaccination, further treatment if it is necessary)
