CALL FOR APPLICATIONS FOR SUBSIDIZED HOUSING FOR FIRST-YEAR STUDENTS OF THE STIPENDIUM HUNGARICUM PROGRAMME

FOR THE 2024/25 academic year

The Directorate of Dormitories of Semmelweis University, in cooperation with the Center of International Training Programs and with the involvement of the Students of Semmelweis University, invites applications for subsidized accommodation for the academic year 2024/25, based on the Semmelweis University Organizational and Operational Regulations Part III. Student Standards Chapter III.4. Remuneration and Benefits Policy (hereinafter referred to as: RBP).

The call for applications is open to freshmen (will be enrolled for 1st year in 2024/2025) students participating in the Stipendium Hungaricum programme.

The Directorate of Dormitories is responsible for the application procedure.

A successful application will be considered invalid if

- the applicant does not enrol at the university after admission

Application procedure:

The applicant submits the application electronically under the Students' Union – Application - Applications for Subsidized Housing for Stipendium Hungaricum Scholarship Holders menu providing their details.

The **Declaration** (see below) must be completed and sent to hoc.applications@semmelweis.hu at the same time as the application. If the properly completed and signed document is not sent by the end of the application period, the applicant's application will be invalid.

Application period:

from 4th of July, 2024 (10:00:00) till 12th of July, 2024 (23:59:59).

Additional rules of application

Applicants declare that in case of a successful application, they will enter into a contract with Semmelweis University and Óbuda Student Hotel. It is a fixed term contract for the

duration of 1 year and will include the payment of additional fees and it stipulates that the student will not receive the housing allowance if they move out before the end of the fixed term.

The **Declaration** must be completed and sent to hok.applications@semmelweis.hu at the same time as the application. If the properly completed and signed document is not sent by the end of the application period, the applicant's application will be invalid.

The applicant may also apply to any other Semmelweis dormitory, but in this case you will be placed at the bottom of the waiting list (see the updated waiting list at https://semmelweis.hu/hok/en/applications/application-for-dormitories/).

The student has the right to appeal, which they can do within 15 days of obtaining the result by sending an email to hok.application@semmelweis.hu.

After the closing of the application window, the Directorate of Dormitories together with the Social Committee will determine the final shortlist of candidates. Based on the order of application submission, the admission ranking of the Óbuda Student Hotel will be established and the Directorate of Dormitories will notify the students.

Applicants who are not admitted to the Óbuda Student Hotel will be put on a waiting list. As soon as accommodation at the Óbuda Student Hotel becomes available, it will be offered to the student at the top of the waiting list.

Students admitted successfully to the Óbudai Diák Hotel may cancel their place without any consequences within 5 days of the notification of the admission decision in writing via e-mail to nagyistvan.csilla@semmelweis.hu. In the event of cancellation after the above indicated deadline, the student will be charged the fee for the academic year 2024/2025.

Admitted students must take their place at the Hotel on the date set for moving in. If you are unable to do so, you must inform the Óbuda Student Hotel and the University in writing (nagyistvan.csilla@semmelweis.hu), otherwise your accommodation will be given to another candidate from the waiting list.
