SEMMELWEIS UNIVERSITY

STATUTES - DEED OF ESTABLISHMENT

in a consolidated structure with its amendments

The vision of Semmelweis University is to become an institution considered among the world's leading universities in the field of medical and health sciences and closely related social sciences by ensuring the unity of theoretical education, basic and translational research, and clinical practice while respecting tradition and making extensive use of the results of modern technology, in training professionals of excellence in the fields of medicine and related sciences, management and education, and apply the highest methods of medical practice, focusing on health promotion, disease prevention, personalized medicine, and social expectations, for the advancement of the nation.

Act CCIV of 2011 on National Higher Education (hereinafter: Nftv.) Article 8 Section (4); Article 73 Section (3) a), and pursuant to Act XX of 2021 on the National Foundation for Health and Medical Education, the National Foundation for Health and Medical Education and the Semmelweis University on the transfer of assets to the Semmelweis University, and pursuant to Act IX of 2021 on public interest trusts performing public functions, Section 2 (1). (hereinafter: KEKVA tv.) 22.§ (1) of the Statutes of Semmelweis University, I hereby issue the following:

II. Governing body of the University

1. Data of the governing body:

2. Rights and obligations of the Governing body

2.1. The Governing body shall exercise all the rights and obligations conferred on the governing body of higher education institutions by the legislation in force.

2.2. Within the framework of the current legal mandate, the competences of the Governing body and the Senate are defined in the following areas:

2.2.1. The governing body approves the budget framework for the institution of higher education, within which the senate approves the university's annual institutional budget, which it is required to submit to the governing body for review. If the holder does not agree with the budget, it shall

return it to the University, giving a reasonable deadline, and request that it be revised. The University is obliged to comply with the request or objection of the Governing body.

- 2.2.2. The Governing body shall adopt the annual accounts of the University, prepared in accordance with the accounting provisions, in respect of which the Senate shall have the right to express an opinion.
- 2.2.3. The Governing body shall, upon its scope of rights, by Article 94 paragraph (2a) of the Nftv., Article 73 paragraph (3), lit. ca), shall examine the University's Organizational and Operational Rules. The University shall send its Organizational and Operational Rules and any amendments thereto to the governing body within fifteen days of the decision of the Senate. The Governing body shall communicate its comments on the Rules of Organization and Operation to the University within a maximum of thirty days from the date of their dispatch, which due date may be extended once by a maximum of thirty days. If the Governing body disagrees with the provisions of the Organizational and Operational Rules, it shall return them to the University, setting a reasonable deadline, and initiate a revision. The University is obliged to comply with the request or objection of the Governing body. The measure or decision contested by the Governing body cannot be implemented. The objection communicated by the Governing body shall override the contested decision of the University concerning the University's Rules of Organization and Operation.
- 2.2.4. With regard to the institution's asset management plan, as well as the establishment of a business entity by the university and the acquisition of a stake in a business entity, the Statutes (Deed of Establishment) does not deviate from the provisions of the Nftv. Article 12 paragraph (3), and the powers of the governing body under Article 73 paragraph (3).
- 2.2.5. The Senate proposes the content of the Rector's call for applications, evaluates the Rector's applications and elects the Rector's candidate, evaluates the Rector's leadership activities, the Governing body, taking the Senate's proposal into account, calls out the Rector's application, initiates the appointment and dismissal of the rector-designate elected by the Senate, and exercises the employers' rights over the Rector.
- 2.2.6. The Governing body shall appoint and dismiss the Chancellor and exercise the rights of an employer.
- 2.2.7. The governing body gives its prior opinion on the University's institutional development plan. The governing body shall, upon its scope of rights, by Article 94 paragraph (2a) of the Nftv., The Governing body shall, upon its scope of rights, set out in Article 73 paragraph (3) lit. cb) of the Nftv. examine the University's institutional development plan. The institution shall send the institutional development plan and any amendments thereto to the Governing body within fifteen days of the decision of the Senate. The Governing body shall communicate its comments on the institutional development plan to the University within a maximum of sixty days from the date of their dispatch, which due date may be extended once by a maximum of thirty days. If the Governing body disagrees with the institutional development plan, it shall return it to the University, with a reasonable deadline, and initiate its revision. The University is obliged to comply with the request or objection of the Governing body. The measure or decision contested by the Governing body cannot be implemented. The objection communicated by the Governing body shall override the contested decision of the University concerning the University's institutional development plan.

III. Purpose and Legal Status of the University

1. The Semmelweis University's (hereinafter: University) is a public benefit activity institution in accordance with the Nftv. Section 2 (1) and (3), with the aim of pursuing educational and scientific research activities, including, in particular higher education vocational training, bachelor's, master's, doctoral and postgraduate training.
2. The University is based on the principle of the unity of education, scientific research, hereinafter referred to as scientific research, development and innovation, and health care.
3. The University is a state-recognized higher education institution of Hungary under the Nftv., a non-state-owned University, a legal entity participating in the performance of public tasks as defined in the KEKVA Act. (hereinafter: KEKVA tv.)
4. The University operates as a public benefit organization under the provisions of the Nftv. and Act CLXXX of 2011 on the Right of Association, the Public Benefit Status, and the Operation and Support of Non-Governmental Organizations and based on the registration of the Education Office.

IV. Activities of the University

1. The core activities of the University are education, scientific research, and the operation of the University as a vocational training institution according to Act LXXX of 2019 on Vocational Training and Act LXXVII of 2013 on Adult Education, and as a public education institution according to Act CXC of 2011 on National Public Education, and the operation of the University as a public education institution according to Act Nftv. Section 97. (1) a) and provides health care services through the Clinical Center maintained by it. Regarding these activities, the governing body shall perform its public tasks under the KEKVA Act through the University.
2. In the course of its activities, as set out in point 1, the University shall:
 - 2.1. In the field and at the level of education specified in Title VI, it may provide bachelor's, master's, postgraduate, doctoral, and specialized further education and award diplomas in these courses to Hungarian and international students.
 - 2.2. It participates in implementing vocational training not classified as higher education and other training and further training tasks specified in the sectoral laws and conducts language preparation and language examinations.
 - 2.3. The higher education institution participates in training medical specialists, dentists, pharmacists, clinical psychologists, and public health specialists, including the training and further training of other higher education graduates in the health care field, under the provisions of the relevant legislation.
 - 2.4. Under the Nftv., Act CLIV of 1997 on Health Care and Act LXXXIII of 1997 on Compulsory Health Insurance Benefits, it shall perform tasks within the scope of health care, including care(s) with territorial coverage obligations and special health care service(s), following the provisions of the relevant

- legislation. For this, it shall establish and maintain a health care provider as a clinical center or a business entity established in a separate organization from the University.
- 2.5. It conducts essential, applied, and experimental research; development projects; research management; technological innovation; and other research supporting education in the fields and disciplines related to the program, including conductive pedagogy, psychology and related medical sciences, and the independent and interdisciplinary areas of the social sciences.
 - 2.6. As the founder and governing body of a public education institution, it performs public education tasks; as a teacher training institution, it is the governing body of public education institutions - operating as a legal entity of a higher education institution under Article Article 14 paragraph (3a) of Nftv - it performs professional services, kindergarten, and school, traveling special education teachers, traveling tutors and pedagogical-professional service activities.
 - 2.7. It provides all-age habilitation and rehabilitation to ensure the conductive education of children and adults with cerebral palsy and related disorders due to damage to the central nervous system. It provides special teacher training. The public education institutions it runs provide preschool, primary and vocational education, and complex conductive education for children and pupils with musculoskeletal disabilities, mild intellectual disabilities, and intellectual disabilities. Within the framework of the provision of specialized services, it carries out specialized tasks in special educational counseling, early development and care, educational counseling, and conductive pedagogical care. It maintains a specialized pedagogical service, a network of itinerant special education teachers (conducting network), itinerant teachers, primary schools, dormitories, and school health services within the single special education and conductive pedagogical methodology institution.
 - 2.8. Pursuant to Article 14 paragraph (3A) he of the Nftv. as the operator of a vocational training institution that functions as an organizational unit of the University with legal personality, it carries out vocational training tasks. The University operates an accredited examination center under Act LXXX of 2019 on Vocational Education and Training, which operates as its separate legal entity. It provides education and training in vocational schools, vocational secondary schools, and vocational gymnasiums, vocational training in technical and vocational schools, education and training in adult education, and education and training in schools for children and pupils with special educational needs who can be educated and trained together with other children and pupils. Also, it provides non-educational activities related to education and training.
 - 2.9. It publishes textbooks and notes, develops teaching aids, provides textbooks and notes, library and laboratory services, dormitory accommodation, and cultural and sports facilities for students and pupils.
 - 2.10. It publishes and distributes professional journals and periodicals.
 - 2.11. Performs tender and project management activities related to national and international tender participation.
 - 2.12. The University performs its tasks concerning the operation and maintenance of its infrastructure and its continuous development within its organization, for the fulfillment of which it operates internal service and functional departments and an internal audit department. In this context, it operates service and functional departments, in particular financial, controlling, accounting, legal, organizational-administrative, labor, IT, asset management, technical, personnel and property protection, facility management, operations, logistics, services, procurement, and public procurement, and operational services and functions.
 - 2.13. The University runs service units for preventive medicine, rehabilitation, conductive education, dormitories, social services, sports, libraries, and archives.
 - 2.14. It offers courses in preparation for admission and other courses.

- 2.15. It carries out public collection activities and public cultural tasks.
- 2.16. It provides non-funded curative, health, and public health services within the health promotion framework.
- 2.17. It ensures the development of student talent and the training of teaching, research, medical and health professionals.
- 2.18. According to the Act CLIV of 1997 on Health Care, forensic medical and mental health practitioners carry out organizational-methodological, further training, and scientific-research activities in the field of expert activities, within the framework of which their tasks include in particular:
 - a. national data collection, data processing concerning forensic medical examinations,
 - b. carries out continuous analysis of data relating to extraordinary mortality in Budapest,
 - c. contributes to the drafting of professional rules on forensic medicine, initiates the preparation of legislation on forensic medicine, and provides opinions on such legislation,
 - d. proposes the introduction of new procedures and methods in forensic medical practice and measures to facilitate the standardization of forensic medical practice,
 - e. assists the institutions in the field from a professional and methodological point of view,
 - f. participates in the development and enforcement of quality assurance criteria for forensic medical and mental health expertise,
 - g. cooperates with the Forensic Medicine, Medical Expertise, and Insurance Medicine Boards of the Health Professional College in preparing professional guidelines and methodology bulletins.

V. Organization, representation, and institutions of the University

- 1. The higher education institution's educational and scientific research activities shall be organized into faculties, clinics, departments, departmental groups, and doctoral schools.
- 2. The higher education institution is organized into faculties. The faculties organize the tasks of training in one or more fields of training, at one or more levels of training, which are related in terms of subject. The Faculties of the University are as follows:
 - 2.1 Faculty of General Medicine,
 - 2.2. Faculty of Public Health Services,
 - 2.3. Faculty of Health Sciences,
 - 2.4. Faculty of Dentistry,
 - 2.5. Faculty of Pharmaceutic Sciences,
 - 2.6. Pető András Faculty.
- 3. The higher education institution operates functional and service organizational units to fulfill its tasks.
- 4. The organizational structure and operational rules of the higher education institution within the above framework are set out in the organizational and operational regulations.

7. The Senate:

7.1. The University's main decision-making body is the Senate.

7.2. The composition of the Senate, the rules for its establishment, its duties, and its powers shall be determined in the Rules of Procedure and Organization, considering the exercise of the powers provided for in this Statute.

8. The Rector

- 8.1. The Rector is the primary responsible head and representative of the University, appointed or dismissed by the President of the Republic of Hungary through a public tender following the relevant provision of the Nftv. The term of office may be up to five years, renewable twice in accordance with the Organizational and Operational Rules of the University. The governing body shall exercise the rights of the employer.
- 8.2. The Rector shall act and decide on all matters not referred to the competence of any other person or body by law, the founding charter, the organizational and operational regulations, or the collective agreement.
- 8.3. The Rector shall be responsible for the management of the University's essential activities, the continuous development of education, scientific research and patient care, and in this context shall manage or exercise the right of maintenance, as defined in the Organizational and Operational Regulations, of the clinical center and the public educational and vocational training institutions operating under the University's maintenance.
- 8.4. The Rector exercises the right of employer in the exercise of their duties and powers. The Rector shall appoint the President of the Clinical Center, and the appointment of the President of the Clinical Center shall be subject to the prior consent of the Minister responsible for health. The Rector shall exercise the rights of the employer over the President of the Clinical Center, with the exception that the President of the Clinical Center shall exercise the rights of the employer over the employees of the Clinical Center employed on health service contracts, except for decisions concerning the management of wages which are subject to the Chancellor.
- 8.5. The Rector represents the University in international relations. The Rector coordinates professional relations with domestic higher education institutions and cooperation with national higher education organizations. The Rector represents the University in the Hungarian Rectors' Conference.
- 8.6. The Rector, or by decision of the Vice-Rector appointed by them, shall exercise professional supervision over the activities of companies established by the University or with the participation of the University.
- 8.7. In matters within their competence, maintains contact with interest representation organizations, student and doctoral student self-government.

9. The Chancellor:

- 9.1. The governing body shall, upon its scope of rights, by Article 94 paragraph (2a) of the Nftv., with the duties and powers set out in this point, shall establish the position of Chancellor as a senior employee. The Governing body shall exercise the rights of the employer.
- 9.2. The Chancellor is responsible for the University's economic, financial, controlling, internal audit, accounting, labor, legal, organizational-administrative, IT, and property management, including technical, facilities management, operation, logistics, services, and procurement, and public procurement.
- 9.3. The Chancellor shall exercise the rights of the owner in companies established by the University or with the participation of the University. The Governing body shall appoint and dismiss the Chancellor and exercise the rights of the employer.
- 9.4. The Chancellor shall be the head and representative of the University regarding his specific duties and powers set out in this section and shall be responsible to the Governing body.
- 9.5. The Chancellor directs the activities of the departments falling within their scope of responsibility and authority, as set out in the Organizational and Operational Regulations, and exercises the employer's power within this scope.

9.6. The Chancellor shall exercise the right of financial countersignature in respect of decisions of the Senate with financial implications concerning the commitments of the Rector and the President of the Clinical Center and consideration of matters specified in the Statutes to ensure the economic conditions, which shall be a condition of validity of decisions/commitments of the Senate and of the Head of the University specified in the Statutes which have financial implications. The chancellor, who is appointed by the governing body, may attend meetings of the Senate as a permanent guest.

The Rector and the Chancellor cooperate in managing the University's activities.

- 4 The University shall exercise the rights of the owner in respect of the property entrusted to it, subject to the provisions of the KEKVA Act and, in the case of other titles, the rights under the contract on which the title of use is based. The real estate properties may be used for the University's core (public benefit) activity.

VIII. Entrepreneurship at the University

- 1 The University uses its free infrastructure capacities (in particular publishing activities, production of printing products and the provision of printing services, workplace catering, and the rental of sports facilities), which is essentially not for profit but supports the performance of the core public benefit activity.
- 2 Activities carried out in cooperation with economic operators to develop and improve the quality of education, research, and patient care or to incorporate new research results into teaching and patient care to raise the quality of essential public benefit activities are not considered entrepreneurial activities.
- 3 The University shall not distribute its profits and shall use them for the public benefit activities defined in this Deed of Establishment.
- 4 The University is entitled to carry out entrepreneurial activities to the extent that they do not jeopardize its core activities.

IX. The University's Public Benefit Status

- 1 The University carries out its essential activities, education and scientific research as public benefit activities, subject to the provisions of the KEKVA tv. Annex 1 point No. 18 regarding the public service tasks.
- 2 The University does not engage in direct political activity, is independent of political parties, and does not provide financial support to them.
- 3 This Statute authorizes the University to provide in its internal regulations:
 - a. the keeping of a register from which the content, date, and scope of the decision of the decision-making body and the number (if possible, the identity) of those in favor and those against the decision can be ascertained,
 - b. how decisions are communicated or made public to the persons concerned,
 - c. the arrangements for access to documents relating to the operation of the public benefit purpose organization, and
 - d. on the publicity of the operation of the public benefit purpose organization, how it uses its services, and the publication of its reports.
- 4 The University has a 3-member Public Benefit Supervisory Board (KFB) appointed by The University has a three-member public benefit supervisory board, whose members are appointed by the Governing body and have a legal relationship with the University. The Public Benefit Supervisory Board (KFB) controls the operation and management of the public benefit organization, monitors the University's core public benefit activities, and, in this context, may inspect documents relating to the University's management, ask questions and request information from the heads of the University's departments, and also have access to the documents of the University's leadership, the public benefit status, and the operation and support of non-governmental organizations, as defined in the Act on the Right of Association, the Public Benefit Status, and the Functioning and Support of Non-Governmental Organizations in Act CLXXV of 2011. It gives its opinion on the University's institutional budget, annual accounts, and annual report on public benefit.
- 5 The Public Benefit Supervisory Board shall initiate the convening of a meeting of the Senate after informing the Sustaining Body if it detects any violation of law or any omission that seriously harms the interests of the University or the Sustaining Body, the elimination of which or the removal of the consequences of which requires a decision of the Senate.
- 6 If the body or organ entitled to do so fails to take the necessary measures to restore lawful operation, the Public Benefit Supervisory Board shall immediately notify the Governing body.
- 7 The KFB monitors the fulfillment of the University's threefold mission of teaching, research, and patient care, as set out in the University's Statutes.
- 8 The KFB shall establish its rules of procedure.
- 9 A member of the KFB cannot be a person who:
 - a) is the Rector, the Chancellor, or any member of the Senate,
 - b) has an employment or other employment relationship with the public benefit purpose organization for the performance of activities other than those for which they are responsible unless otherwise provided by law,
 - c) benefits from the charitable organization's intended use, except for non-monetary services that are available to anyone without restriction, or
 - d) a close relative of a person referred to in points (a) to (c).

X. Final provisions

The present Statutes are approved by the Decision No. 28/2026 (27 April) of the National Foundation for Health and Medical Education, and at the same time, the Statutes on the Deed of Establishment No. 63/2025 (4 November) of the National Foundation for Health and Medical Education shall be repealed.

The present Statutes shall enter into force on 27 April 2026.
