## 4. INFORMING DATA SUBJECTS ABOUT THEIR FUNDAMENTAL RIGHTS AND THE WAYS TO EXERCISE THEM

## 4.1. RIGHTS OF DATA SUBJECTS

## 4.1.1. Right to information

Data subjects have the right to receive information in a concise, transparent, intelligible and easily accessible form, using clear and plain language. The Controller shall comply with such a request by the data subject in writing or by any other appropriate means, after verifying the identity of the data subject, without undue delay but not later than 1 month. The Controller shall provide such information free of charge, unless the request is unfounded, excessive or repetitive.

#### 4.1.2. Right of access

Data subjects are entitled to have access to their personal data and to the following information: a copy of their personal data (additional copies are available for a fee)

# 4.1.3. Right to rectification

Data subjects are entitled to rectify or complete inaccurate data without undue delay.

# 4.1.4. Right to erasure ('right to be forgotten')

At the request of the data subject, the Controller shall delete personal data relating to the data subject without undue delay if any of the following applies:

- the purpose has become obsolete, the data are no longer necessary
- the data subject withdraws his or her consent and the legal basis for the processing therefore ceases to exist
- the data subject objects to the processing
- unlawful processing
- to comply with a legal obligation

In the case of processing based on consent, data subjects have the right to withdraw their consent at any time, which does not affect the lawfulness of the processing carried out on the basis of consent prior to the withdrawal.

In the context of the data subject's right to be forgotten, if the Controller is obliged to delete personal data that has been disclosed, the Controller shall take reasonable steps, taking into account the available technology and the cost of implementation, to inform other data controllers about the deletion of the links, copies or duplicates in question. An exception to this provision shall be made where the processing is necessary

- for freedom of expression
- to comply with a legal obligation or to exercise official authority powers
- for reasons of public interest in the field of public health

- consent

  Data subjects are entitled to
- request human intervention
- express their point of view
- lodge an objection.

- for archiving in the public interest, for the purposes of scientific or historical research
- for the enforcement of legal claims

## 4.1.5. Right to restriction of processing

The Controller shall restrict processing at the request of the data subject if

- the data subject challenges the accuracy of the personal data
- the processing is unlawful and the data subject objects to the erasure of the data
- the Controller no longer needs the personal data but the data subject requests them for the establishment, exercise or defence of legal claims
- the data subject has objected to the processing and the Controller is still investigating the matter.

## 4.1.6. Right to data portability

Data subjects shall have the right

- to obtain the data which they have provided to the Controller in a structured, commonly used, machine-readable format
- to transmit their data to another data controller to request the direct transfer of their data to the other data controller

# 4.1.7. Right to object

Data subjects can object to the processing of their data

- on grounds of public interest/public authority and on the basis of the balancing of interests
- for direct marketing purposes
- for profiling with the purpose of direct marketing In the event of the data subject's objection, processing must be stopped immediately, except in the case of compulsive and justified grounds and in order to enforce legal claims.

Rights in relation to automated decision-making and profiling

The data subject has the right not to be subject to solely automated processing, including profiling. Exceptions to this are

## 4.2. OPTIONS FOR LEGAL REMEDY

#### 4.2.1. Right to contact the Data Protection Officer

In case of prejudice, data subjects have the right to seek the assistance of the Data Protection Officer of the Controller to enforce their rights before the Controller. The Data Protection Officer shall assist the data subject in exercising their rights, investigate the data subject's complaint and initiate the necessary measures with the Controller to address the complaint.

# 4.2.2. Right to lodge a complaint with a supervisory authority

Supervisory authority: National Authority for Data Protection and Freedom of Information (hereinafter "the Authority" or " NAIH"), address: 1055 Budapest, Falk Miksa utca 9-11., mailing address: 1363 Budapest, Pf. 9.

## 4.2.3. Right to an effective judicial remedy

If the Authority does not make a decision on the complaint or does not provide information about it within 3 months, the data subject has the right to take the matter to court.

Right to judicial remedy against the data controller/processor

Irrespective of the authority procedures and other procedures, the data subject may take legal action against the data controller and the data processor at the competent court based on the business location of the data controller/processor. Legal proceedings may also be initiated in the courts of the Member State in which the data subject is resident.

The competent ordinary court for the Controller is the Administrative and Labour Court of Budapest, Metropolitan Court of Budapest (1055 Budapest, Markó u. 27.)
