The goals of the course in point of view of the education: Teaching Psychiatry is an integral part of the general medical clinical subjects within the curriculum of the undergraduate education at the Faculty of Dentistry. The aim of the instruction is to acquaint students with the professional terms of psychiatry, its diagnostic and therapeutic methodology, and the clinical features of the most common diseases. We pay special attention to the psychiatric conditions relevant in dental practice, especially to teach dental aspects of common psychiatric illnesses.
Location of the course (address of lecture hall, seminar room etc.): The joint lecture hall of the Department of Psychiatry and Psychotherapy and that of the Department of Neurology.
Competences acquired by completion of the course: <ul style="list-style-type: none"> - theoretical knowledge of the professional vocabulary used in Psychiatry - the ability to identify the clinical features of the most common psychiatric disorders - the ability to identify psychiatric conditions and common psychiatric diseases in dental practice - the skill of applying the diagnostic and therapeutic methodology Description of skills and (sub) competencies: <ul style="list-style-type: none"> • Recording of psychiatric medical history (general, familial, somatic, psychiatric, pharmacological) • Psychiatric examination (consciousness, perception, orientation, thinking, intellect, emotional and mental functions, mood, assessment of psychomotor functioning, examination of behaviour, motivation and personality) • Knowledge of major psychiatric disorders, their recognition • identification of dental significance of psychiatric disorders • Recognition of emergency psychiatric conditions • Recognition of somatic disorders underlying psychiatric symptoms • Assessing an imminent threat, then taking the necessary interventions, initiating legal measures • Differential diagnosis of psychiatric disorders
Pre-study requirements and prerequisites of course registration and completion: Internal Medicine I., Pharmacology I.
Number of students required for announcement of course (min., max.): We do not restrict the number of students who can enroll to our course.
Method of course registration: Course registration shall be made on the Neptun system by students who wish to enroll.

Detailed course/lecture description²: *(to facilitate credit recognition in other institutions)*

Main topics of the course are classification in psychiatry, schizophrenia and other psychotic disorders, mood disorders, anxiety, anxiety disorders, somatoform disorders, substance use disorders, organic mental disorders. Emergency care and legal aspects in psychiatry are discussed. Both theoretical and practical aspects of the different conditions are concerned. We deal with the special importance of doctor-patient communication within psychiatry.

The course is fourteen week long, one lecture per week. Case demonstrations are also fit into the framework of the lectures.

1 st week	The subject of psychiatry, classification of disorders, diagnostic methods (lecture – Prof. János Réthelyi)
2 nd week	Case demonstration (psychiatric interview, signs and symptoms (lecture Dr.Z. Hidasi)
3 rd week	Affective disorders (lecture – Z. Hidasi)
4 th week	Case demonstration (depression – Z. Hidasi)
5 th week	Schizophrenia and other psychotic disorders (lecture – Á. Menus)
6 th week	Case demonstration (schizophrenia – Z. Hidasi)
7 th week	Anxiety, anxiety disorders, somatoform disorders (lecture – Z. Hidasi)
8 th week	Substance use disorders (lecture – A. Bodrogi)
9 th week	Case demonstration (substance use – Z. Hidasi)
10 th week	Case demonstration (anxiety disorder – Z. Hidasi)
11 th week	Organic psychiatry (lecture – Dr. Zoltán Hidasi)
12 th week	Case demonstration (dementia – Dr. Zoltán Hidasi)
13 th week	Emergency in psychiatry, legal aspects (lecture - Dr. Zoltán Hidasi)
14 th week	Case demonstration, consultation (Dr. Zoltán Hidasi)
