EXCERPT OF RECTOR'S ORDER No. R/7/2020. (V.22.)

on changes in the arrangements of visits to institutions and on transitional measures to organize makeup practical lessons

According to the protective measures in the capital at paragraph (1) § 7 of Government Decree 211/2020 (V.16.) (hereinafter: Gov. Decr.), and acting in my jurisdiction under Paragraph 12 § 3 and paragraph 12 § 2 of Section I.1. as well as under paragraph (3) and (4) § 3 of Section I.10. within Semmelweis University Organizational and Operational Regulations (hereinafter: O.O.R.), I issue the following provision:

§ 1 Students affected by changes in the order of institutional visits

I will lift the ban on visiting institutions from 25 May 2020,

- (1) in all faculties of Semmelweis University (hereinafter: the University) for students of the years included in paragraph (2) of this section, as well as for students of certain subjects in accordance with paragraph (2) and subject to paragraph (1) and (2) § 7 of the Government Decree regardless of the nature and language of the training. From this date, students of the relevant years at the university, as well as students enrolled in certain subjects, are required to attend in person.
- (2) Participants in years and courses affected by the lifting of the ban from 25 May 2020 are required to attend in the following cases:
- a) Faculty of Medicine year IV-V,
- b) Faculty of Dentistry year III-IV,
- c) Faculty of Pharmaceutical Sciences year III-IV,
- d) year I-II students enrolled in the Anatomy subject of the Faculty of Medicine and the Faculty of Dentistry,
- e) year II students enrolled in the Physiology subject of the Faculty of Medicine and the Faculty of Dentistry,
- f) year I students enrolled in the Introduction to Patient Care subject of the Faculty of Medicine.
- g) year II students enrolled in the Introduction to Clinical Studies subject of the Faculty of Medicine.
- h) year II dentistry students enrolled in the General Dental Preclinical Practice subject of the Faculty of Dentistry,
- i) year II dentistry students enrolled in the Conservative Dentistry and Endodontics, Preclinical Course subject of the Faculty of Dentistry,
- j) year II dentistry students enrolled in the Odontotechnology and Prosthodontics Preclinical Course subject of the Faculty of Dentistry.
- (3) It is the responsibility of the Dean to take the necessary measures to organize the examination. In the case of an examination held in person, only the relevant provisions of the

- TVSZ (study and examination rules) shall apply, excluding the case specified in paragraph (4) §2. In the cases specified in paragraph (1) point d) e), the theoretical part of the examination may also be organized through distance examination with the permission of the Rector.
- (4) In the case of an examination held in person, the student must bring a document certifying the completion of the physical check-up ordered under the epidemiological measure to the examination or an official document issued under the epidemiological measure. In the case of students who are Hungarian citizens staying in Hungary at the time of the epidemic, this provision only applies to persons who come into contact with patients during their practical lesson or examination.
- (5) Following the personal appearance of the students, the necessary epidemiological measures must be met during the organization of the education and examination, in particular the mandatory protective distance must be maintained and the wearing of a mask must be compulsory.
- (6) The personal appearance of a foreign student at the university is subject to a preliminary epidemiological measure (negative COVID-19 virus test) based on the information of the relevant Rector's Order.

§ 2 Order of make-up practical lessons

- (1) In the case of those subjects for which the making-up of the internships is necessary, its order is determined by the Rector on the basis of a proposal given by the Dean with the consent of the HÖK.
- (2) The making-up of practical lessons during the examination period or for a maximum period of 30 days following the examination period may be determined for students in the 2nd semester of the 2019/2020 academic year. The Rector may, on the proposal of the Dean, with the consent of the HÖK, authorize the making-up of practices for certain subjects in the first semester of the 2020/2021 academic year, provided that this does not lead to a disproportionate increase in students' academic obligations.
- (3) In the case of the Faculty of Medicine and Dentistry students, the completion of first year summer internships if there are obstacles their completion can be completed after the 2nd year on the proposal of the Dean.
- (4) If the internship is completed after the examination, paragraph (4) and (7) § 1 of Rector's Order R / 4/2020 (IV.22.) on the transitional study and examination rules related to the organization of the examinations should be applied. If the practice is completed before the examination, the provisions of the TVSZ shall apply to the organization of the examination.
- (5) In the case of the András Pető Faculty, the conditions and the start of the completion of the internship is the date of the reopening of public education institutions.

(6) Regarding the completion of the internship - if it does not fall within the scope of § 1 - the Rector also decides, if necessary, to lift the ban on visiting the institutions of the students involved in the internship.

(7) Students will be notified of the method of internship completion by the Faculty through the Neptun system, with the student being notified in due time of the possibility of completing the internship.
