I, the undersigned, as the legal representative, declare under penalty of perjury that:

- 1. **My legal representative authority is not limited**; I am authorized to make a legal declaration in the name of the above-named person.
- 2. I acknowledge that, under Hungarian law, a person under the age of 18 is a minor with limited legal capacity and may therefore make legal statements during application and admission to an institution of higher education independently only within a limited scope. The same applies to any legal statement while holding student status until reaching the age of majority. Legal representation is required when a minor undertakes acts with legal obligations.
- 3. I have read, understood, and accept the provisions of the "Rules and Principles for Application and Admission" document (available here: <a href="https://semmelweis.hu/registrar/admission-rules">https://semmelweis.hu/registrar/admission-rules</a>), and the "Student Contract" (available here: <a href="https://semmelweis.hu/registrar/student-contract">https://semmelweis.hu/registrar/student-contract</a>), which set out the rules for application, and in the event of successful admission the training, and its cost coverage for the minor.
- 4. **I provide my unconditional and irrevocable consent** in application matters of the minor named in this declaration, who is under my legal representation

  - b) to the minor signing the Student Contract in the event of successful admission, and *I accept the obligations set forth in the Student Contract as binding* with respect to the person I represent.

  - a) to cover all costs incurred during the full admission procedure and tuition fees,
  - b) to provide my bank account details,
  - c) in the event of successful admission, to fulfill any obligations contained in the Student Contract concluded by the minor I represent,
  - d) to report any changes in my data provided within this declaration within 8 days.
