

## **Information on the completion of traineeships abroad**

Criteria for the selection and acceptance of traineeship abroad at the Faculty of Medicine:

1. In the countries of the European Union (with the addition of Switzerland and Norway), traineeship in state-accredited university clinics and their teaching hospitals may be accepted or recognised. The legal basis for this is the mutual recognition of diplomas from the accredited institutions.

Conditions for traineeships in the EU and the USA:

- a) The hospital must be a teaching hospital accredited by an EU/US medical school or be involved in the training of medical students at an EU-accredited university.
- b) The training at the EU/US training site must be in accordance with the list of competencies adopted by the MAB (Hungarian Accreditation Committee) for the clinical practical year for medical students.
- c) The foreign training site must evaluate the student's performance and the head of the relevant department must confirm the completion of the tasks detailed in the list of competences with a signature.
