This agreement sets out the terms and rules applicable to the work performed during the practice placement by *Student* of year 1/3/4/6 of the Faculty of Medicine at Semmelweis University for summer patient care / summer internal medicine / summer surgery / internship year internal medicine / internship year surgery / internship year pediatrics / internship year obstetrics / internship year neurology / internship year psychiatry.

- 1. The *Parties* agree to enter into a definite-term agreement for the period of the practice placement specified in Section 7 in accordance with Section 44 of Act CCIV of 2011 on National Higher Education requiring the provisions of the Labor Code to be applied to the employment of *Student* performing work under this agreement, with the provision that more favorable terms may apply as set out in government decrees.
- 2. According to Government Decree 230/2012.(VIII.28.), in the course of the employment of a student performing work under a student agreement, the student may not be required to work at night nor other extraordinary working hours, the daily working hours of the student may not exceed 8 hours, in the event a work time frame is used, a maximum work time frame for one week may be ordered, the student must be provided with at least a 12-hour rest period a day, no probation period may be ordered and the provisions of Sections 105(2) and 106(3) may not be applied.
