## Preamble

In its decision number 138/2019. (XII.12.), the Senate of Semmelweis University adopted Chapter III.8 about Student Feedback on Teaching Activities (hereinafter: OMHV) of Part III, Student Standards, of the Organizational and Operational Regulations. Considering the provisions set forth in the operative part of the Senate's decision, the leadership of each faculty, in collaboration with the Student Union, shall develop and adopt the faculty-specific rules encompassed within the OMHV Policy.

In any issues not regulated in this Policy, Chapter III.8 about Student Feedback on Teaching Activities of Part III, Student Standards, of the Organizational and Operational Regulations shall prevail.

This document includes the rules regulating Student Feedback on Teaching Activities introduced by the Faculty of Dentistry.

## General Provisions

### *Article 1 [Ad hoc OMHV Committee]*

(1) An 'Ad hoc' Committee shall be established to draft the rules of the OMHV policy at the Faculty. The members of the Committee are the Dean of the Faculty, the Vice-dean for Academic Affairs, the Director of the Center for Educational Development, Methodology and Management (OMSZK), two persons representing the Students' Union, and four teachers of the Faculty.

(2) The convening of the Committee and the designation of its members, having taken into account the provisions of paragraph (1), fall under the authority of the Dean.

### *Article 2 [The assembly of the questionnaires, the method and frequency of completion]*

(1) The survey questionnaires are drafted by the OMHV Committee, which operates under the professional leadership of the Dean of the Faculty. The questionnaires are reviewed annually. Extraordinary reviews may be initiated by the Dean of the Faculty, the President of the Faculty Students' Union, or an instructor teaching a course at the Faculty.

(2) The operation, implementation, and supervision of the Faculty's OMHV Policy are ensured by the Semmelweis University Center for Educational Development, Methodology and Management under the professional supervision of the Faculty Dean.

(3) The questionnaires are completed electronically. The OMSZK is responsible for overseeing the electronic system.

(4)<sup>1</sup> Student feedback on teaching activities consists of the following:

- a) End-of-semester evaluations in NEPTUN: lectures/practical sessions/seminars (compulsory, elective, and optional courses)
- b) Mid-term on-the-spot evaluation of lectures and teaching performance
- c) Mid-term on-the-spot evaluation of seminars
- d) Evaluation of practical sessions and teaching performance at practical sessions

(5)<sup>2</sup> Frequency of surveys:

- a) Feedback surveys for compulsory, elective, and optional courses (lectures, practical sessions, and seminars) are conducted once per semester, during the final two weeks of the academic term.
- b) Students have the opportunity to provide on-the-spot feedback on lectures and the teaching performance of lecturers immediately after the lectures.
- c) Students can provide mid-term on-the-spot feedback on seminars immediately after the seminar sessions.
- d) Feedback surveys for practical sessions and the teaching performance of instructors are conducted once per semester during the final two weeks of the academic term. In practical sessions where multiple instructors alternate throughout the semester, surveys are conducted multiple times, at the end of each block session led by individual instructors.

(6) The surveys specified in points (5) a) and c) are administered through an electronic link provided via NEPTUN. Students shall be given at least 5 consecutive calendar days to complete the surveys.

(7) The Center for Educational Development (OMSZK) shall be responsible to prepare a guide to assist students in completing the feedback surveys. The translation of the surveys into English and German is carried out by the Center of International Training Programs.

(8)<sup>3</sup> The questionnaires are rated on a 10-point Likert scale.

### ***Article 3 [Benefits for students completing the survey]***

(1) Priority access to course and exam registration: In the subsequent semester, students who complete the questionnaires will have access to exam booking two hours earlier than others.

This incentive is implemented in adherence to principles of anonymity and data protection regulations.

(2)<sup>4</sup> Eligibility requirements: To qualify for this benefit, students must complete the feedback questionnaires for at least 5 compulsory, elective, and optional courses (lectures, seminars, and practical classes) they have registered for in the given semester, as outlined in Article 2(5)a.

(3) Opt-out option maintains eligibility: Students who log into the feedback platform and explicitly indicate that they do not wish to provide feedback for a specific course will still be eligible for the benefit.

## Final Provisions

### *Article 4 [Effective date and application of the Policy]*

(1) This Policy shall take effect from the date of the adoption decision by the Faculty Council.

### *Article 5 [Revision of the Policy]*

Pursuant to Decision number 138/2019. (XII.12.) of the Senate, the Ad hoc OMHV Committee shall revise the Policy one year after it was adopted by the Senate.
