Course principles: The role of this subject is to help students acquire the basic vocabulary, grammar and language skills they need for the effective communication in the language they use during their field practice both in their everyday life /'survival language'/ and in their academic studies.							
Brief course summary: The third semester is dedicated to learning how to communicate with clients and colleagues at the pharmacy. Students acquire basic structures and the vocabulary for describing the characteristics of medicines. The course places special emphasis on functional language needed for obtaining and providing information, giving recommendations and instructions and on phrases needed in basic communication at a pharmacy. The semester also focuses on preparing students for the final exam at the end of the 4th semester.

<p>Order of consultations: Individual consultations by email or in person on meeting formerly agreed upon with the teacher via email.</p>

<p>Conditions of attending the classes, amount of acceptable absents, way of presentation of leave, opportunity for makeup:</p> <p>A maximum of 3 absences is allowed (3x90 minutes); if the number of absences exceeds this, the student may make up missed classes in another group (maximum two times) in agreement with the instructor.</p> <p>A student who misses more than 25% of the practical classes will not be allowed to get a signature (Study and Examination Regulations §29). For more than the allowed number of absences, a medical certificate of long-term illness or hospitalization is required.</p> <p>According to the Study and Examination Regulations (§ 28), three tardies count as one absence. Arriving 15 minutes later than the start of the lesson is considered tardiness.</p>

A minimum of 50% (pass) must be achieved in the oral test. Tests for an upgrade may be completed by the end of the first week of the examination period at a time arranged with the instructor.</p> <p>Assessment of the oral test: 0-49% = fail (1) 50-59% = pass (2) 60-74% = fair (3) 75-89% = good (4) 90-100% = excellent (5)</p>
