Course principles:

The role of this subject is to help students acquire the basic vocabulary, grammar and language skills they need for the effective communication in the language they use during their field practice both in their everyday life /'survival language'/ and in their academic studies.

Brief course summary:

The fourth semester is dedicated to learning how to communicate with clients and colleagues at the pharmacy. Students acquire basic structures and the vocabulary for describing the characteristics of medicines. The course places special emphasis on functional language needed for obtaining and providing information, giving recommendations and instructions and on phrases needed in basic communication at a pharmacy. The semester also focuses on preparing students for the final exam at the end of the semester.
