Topics of the course:

The course is built upon conversation using specific terminology and on written/spoken terminology panels. It aims to improve B2 level students' competence in language for specific purposes.

Week	Topic
1.	Introduction, university studies, subjects, specialities Skills: asking for basic information, orientation in medical fields
2.	Parts of the eye, the most common illnesses (short-sightedness, far-sightedness, cataract, glaucoma, etc.), symptoms and treatment. Eye disorders caused by high blood pressure and diabetes Skills: history taking, patient interview, giving advice
3.	Ear-nose-throat diseases, symptoms and treatment. Skills: ENT history taking, informing the patient
4.	Dermatological diseases, symptoms and treatment. Allergy test Skills: dermatological history taking, informing the patient
5.	Infectious diseases. Sexually transmitted and blood-borne diseases Skills: infectological history taking, informing the patient
6.	Endocrine diseases Skills: endocrinological history taking, informing the patient
7.	Midterm test. Presentations
8.	Psychiatric disorders, symptoms and treatment Skills: psychiatric history taking, informing the patient
9.	Oncological diseases, symptoms and treatment Skills: oncological history taking, informing the patient
10.	Surgical treatment of oncological diseases. Histological examination Skills: preparing the patient for surgery, aftercare, reporting on findings
11.	Abdominal surgery, surgical interventions, devices Skills: preparing the patient for surgery, giving advice
12.	Orthopedic diseases, treatment and orthopaedic surgery Skills: history taking, preparing the patient for surgery, informing the patient, giving advice
13.	Endterm test. Presentations
14.	Closing the term. Evaluating the term

Requirements for attending the course and catching-up opportunities:

Attendance of lessons is obligatory. Students are allowed to have two absences per semester. In the case of more absences, the teacher may deny giving signature (TVSz 29§2a)). Students who miss a class can make up for it (two times a semester).

Possibilities to justify absence:

<p>A medical certificate for long-term sickness or hospitalization is required if students are absent more than 2 times.</p>
<p>Midterm and end-term test and possibilities for a retake: Midterm test (week 7) and end of term oral exam (week 14) Topics of the midterm: see the topics of the course. Students who fail the midterm test must retake it outside of the hours of the lesson</p>
<p>Requirements for signature: Attendance of lessons is obligatory. Students are allowed to have 3 absences per semester. In the case of more absences, the teacher may deny giving signature (TVSz 29§2)a). Students who miss a class can make up for it (two times a semester). Students must pass both tests. Active participation is required during the lessons.</p>
<p>Final grade: The evaluation of student performance is based on the marks received for the written paper and the oral exam, and received for active participation in classes. Tests under 50% must be retaken. In the latter case, the mark fail will also be calculated towards the final mark. 0–50% = 1 (fail) 51–60% = 2 (pass) 61–75% = 3 (satisfactory) 76–89% = 4 (good) 90–100% = 5 (excellent)</p>
