Topics of the course: The course is built upon authentic conversations using specific terminology, written/spoken terminology panels and specialist documentation using terminology. It aims to get students from level A1 to level A2 to communicate using terminology; to deepen students' specialist knowledge.	
Week	Topic
1.	Introduction and data acquisition Skill: requesting basic information
2.	Dental specialties and dental specialists Skill: giving directions at a health centre
3.	Teeth and parts of the teeth, dental numbering Skill: assessing the status of the teeth
4.	Toothache and related symptoms Skill: interviewing the patient for present complaints, filling out a treatment card
5.	Regions and parts of the body, diseases and surgical procedures Skill: general anamnesis taking
6.	Infectious diseases, predispositions, lifestyle Skill: general anamnesis taking
7.	Midterm test. Dental instruments and their fields of application Skills: informing the patient, giving instructions
8.	Setting up the diagnosis Skills: informing the patient, expressing probability in the diagnosis
9.	Setting up a management plan Skills: informing the patient, requesting an opinion
10.	Referral about imaging tests Skills: requesting an examination or a consultation, providing information on patient path
11.	Caries and its treatment Skills: preparation for intervention, information
12.	Tooth extraction and its complications. Skills: preparation for intervention, information
13.	Endterm (oral test) assessment. Check-up, advice on dental hygiene
14.	Evaluation of professional language competences
Requirements for attending the course and catching-up opportunities: Attendance of lessons is obligatory. Students are allowed to have three absences per semester. In the case of more absences, the teacher may deny giving a signature (TVSz 29§2a)). Students who miss a class can make up for it (two times a semester).	
Possibilities to justify absence: A medical certificate for long-term sickness or hospitalization is required if students are absent more than 2 times.	
Midterm and end-term test and possibilities for a retake: Midterm test (week 7) and end-of-term oral exam (week 13) Topics of midterms: see the topics of the course.	

Students who fail the midterm test must retake it outside of the hours of the lesson

Requirements for signature:

Attendance of lessons is obligatory. Students are allowed to have 3 absences per semester. In the case of more absences, the teacher may deny giving a signature (TVSz 29§2a)). Students who miss a class can make up for it (two times a semester). Students must pass both tests. Active participation is required during the lessons.

Determination of the final grade:

The evaluation of student performance is based on the marks received for the written paper and the oral exam, and for active participation in classes. Tests under 50% must be retaken. In the latter case, the result of fail will also be calculated towards the final mark.

61–75% = 3 (satisfactory)
