The process of the exam:

The prerequisite of a successfully passed exam is the passing of both parts of the exam. Candidates are allowed to use printed dictionaries in the written part.

The chosen language of the exam is independent of the language of the state-accredited B2 language exam, which is also criterion.  
 Exemption from the University Professional Exam is only possible in case candidates have passed a professional language exam accredited on a state or international level.  
 the Department of Languages for Specific Purposes is responsible for exemptions.
