# Objectives of the course and its place in the medical curriculum:

The course is built upon authentic conversations using specific terminology, written/spoken terminology panels and specialist documentation using terminology. It aims to get students from level A1 to level A2 to communicate using terminology; to deepen students' specialist knowledge.

- dentures
- orthodontia

8. Gingivitis and its treatment

Skills: how to take a medical history of present complaints and give information

9. Tooth decay and its treatment

Skills: how to take a medical history of present complaints and give information

10. Diagnostics of root canal and illnesses of the periodontium, types of endodontic and periodontal treatment, surgery to complete these

Skills: how to take a medical history of present complaints and give information

11. Tooth replacement and types of dentures

Skills: how to inform the patient and ask for a specialist opinion

12. Orthodontia, malformations

Skills: informing the patient, asking for a specialist opinion

13. Test, Impacted wisdom tooth and other surgical interventions

Skills: how to inform the patient and prepare the patient for interventions

14. Assessment of speaking skills
