<b>Objectives of the course and its place in the medical curriculum:</b> The course is built upon authentic conversations using specific terminology, written/spoken terminology panels and specialist documentation using terminology. It aims to get students from level A1 to level A2 to communicate using terminology; to deepen students' specialist knowledge.

<b>Competencies acquired through the completion of the course:</b>  On completion of the course, the students will - know the medical terminology related to basic dentistry terminology - know the vocabulary of known dental conditions - be able to inform patient at A2 level The student -is able to interview patients at A2 level - is able to listen to and understand specialist dentistry language on a familiar subject - can understand a dental history and a description of a disease related to dentistry written on a familiar professional topic - is able to conduct dentist- dentist, dentist-patient dialogue on a familiar professional topic - can summarise a familiar professional text in Hungarian in the target language at A2 level

Detailed course description:

<b>Week</b>	<b>Topic</b>
1.	Introduction, personal data Skills: how to collect information about the patient
2.	Taking patient's data, specialities in dentistry Skills: the clinic and the hospital
3.	The teeth, the oral cavity, toothache and other symptoms Skills: how to make a dental assessment, ask about complaints, keep documentation
4.	The human body, illnesses, operations, lifestyle Skills: how to take a medical history
5.	Examination Skills: how to give information and instructions to the patient
6.	Revision Skills: medical communication (speaking and writing)
7.	Test. Dental imaging examinations Skills: how to give information on the clinical pathway
8.	The diagnosis Skills: how to inform the patient and assess probabilities regarding illnesses
9.	Different steps in therapies Skills: how to inform the patient and ask for a specialist's opinion
10.	Tooth decay and its treatment Skills: how to prepare the patient for interventions
11.	Tooth extraction Skills: how to prepare the patient for interventions
12.	Review Skills: medical communication (speaking and writing)
13.	Test: Writing. Examination practice Skills: medical communication (speaking)
14.	Assessment of the course

**Related subjects due to interdisciplinary fields (both compulsory and elective) and potential overlaps between subjects: -**

**Attendance requirements; conditions under which students can make up for absences and the method of absence justification:**

A maximum 3,5 absences are allowed i.e. 7x45 minutes of absence are allowed ; if the number of absences exceeds this, the student may make up (maximum one occasion) in agreement with the instructor.

<p><b>Method and type of grading:</b> term grade</p> <p>The evaluation of student performance is based on the marks received for the 2 tests. The result of the written test makes up the 40% of the term grade and the result of the oral test makes up 60% of the term grade. Student performance is assessed as follows: 0–49% = 1 (fail) 50–60% = 2 (pass) 61–75% = 3 (satisfactory) 76–89% = 4 (good) 90-100% = 5 (excellent)</p>
