<b>Objectives of the course and its place in the medical curriculum:</b> The course supports students in acquiring the professional language skills necessary for patient care, patient information and documentation in these fields through the specific professional situations of pediatric dentistry and preventive dentistry. The course is built upon authentic conversation using specific terminology, written / spoken terminology panels and special documentation using terminology. The aim of the course is to get students from level B1 to level B2 communication using terminology; to deepen students' specialist knowledge. <b>Main Topics:</b> <ul style="list-style-type: none"> <li>• Paediatric dentistry</li> <li>• Screening , milk teeth care</li> <li>• Preventive dentistry</li> <li>• Dental care of pregnant patients</li> <li>• Dental care of elderly patients</li> <li>• Dental care of disabled patients</li> </ul>

**Related subjects due to interdisciplinary fields (both compulsory and elective) and potential overlaps between subjects: -**

**Attendance requirements; conditions under which students can make up for absences and the method of absence justification:**

A maximum 3,5 absences are allowed i.e. 7x45 minutes of absence are allowed ; if the number of absences exceeds this, the student may make up (maximum one occasion) in agreement with the instructor.

A student who misses more than 25% of the seminars will not be allowed to get a signature (Study and Examination Regulations §29).

**Requirements to obtain the teacher's signature:**

**Examination requirements: -**

**Method and type of grading: term grade**

The evaluation of student performance is based on the marks received for the 2 tests. The result of the written test makes up the 40% of the term grade and the result of the oral test makes up 60% of the term grade.

Student performance is assessed as follows:
